Part B

Accepting Nominations for General Election

President-Elect, a two-year commitment, is a precursor to the presidency. The primary responsibility of the president-elect is the planning of the following year's annual convention. The president-elect also works in tandem with the president to assist in special projects. In the event of the absence of the president, the president-elect conducts the board meetings. Following the one-year term, the president elect becomes president. Special Note: ASAA pays for the president-elect to attend the National Auctioneers Conference and Show.

Secretary, a one-year commitment, maintains the membership rolls of ASAA. The secretary is responsible for recording and distributing the minutes of all meetings of ASAA. Additionally, this position is responsible to keep current with any reporting standards required by state or federal agencies.

Treasurer, a one-year commitment, is responsible to keep full and accurate account of all receipts, bank accounts and investments of ASAA. The treasurer receives membership dues and pays all approved expenditures of ASAA.

Board member: Two positions--three-year commitments. Board members serve as directors of ASAA and assist in special projects and work on committees as assigned by the president.

Criteria for Nomination

1. Must be a current member of ASAA;
2. Must be able to participate in the majority of ASAA events;
3. Shall represent ASAA in a favorable and ethical manner in the community and to fellow ASAA members;
4. Members may nominate themselves;
5. Members may nominate another ASAA member but the nominee is under no obligation to accept the nomination;
6. Nominations will be accepted from the floor at the general meeting.

10. ASAA logo will earn extra points; NAA logo as tie breaker.
